How To Submit a DMCA Claim

If you would like to make a Digital Millennium Copyright Act (“DMCA”) notice against content on our site, section 512(c) of the Copyright Act requires that the “Notice” must be in writing and must include substantially all of the following:

- A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

- Identify in sufficient detail the location (e.g. URL) of copyrighted work. If multiple copyrighted works are covered by a single notification, include a detailed list of all locations of such works.
- Detailed description of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled with sufficient detail so that we can easily find it.
- Information reasonably sufficient to permit us to contact the complaining party, such as an address, telephone number, and, if available, an e-mail address at which the complaining party may be contacted.
- A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- A statement that you swear, under penalty of perjury, that the information in the notification is accurate, and that you are the copyright owner or are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

The provider of affected content may make a counter notification pursuant to the DMCA. When we receive a counter notification, we may reinstate the material in question.
